#### **Terms and Conditions:**

- 1. Students entitled for more than one scholarship / fee concession under different categories shall be given scholarship / fee concessiononly under one category as opted by the student.
- 2. Student will be entitled for only one type of scholarship either from DAV University or any other external scholarship being provided by government / private agencies/ NGOs.
- 3. This Policy will be applicable for the year 2019-20 only and the same will not be treated as a precedent for the forthcoming years.
- 4. Grant of Scholarship is subject to verification and authentication of information, certificates and other documents to be submitted within stipulated period of time as per the notification of the University.
- 5. The scholarship will be credited / adjusted in the fee for even semester.
- 6. Scholarship is not applicable to PG Diplomas, Short Term Courses and Part time Courses.
- 7. In case of any dispute, decision of DAV University will be final for all intents and purposes.
