I shall not indulge in any kind of cyber crime including cyber-stalking, Dissemination of obscene material, defamation, hacking, cracking, e-mail spoofing, SMS spoofing, carding, cheating and fraud, pornography, assault by threat, intellectual property crimes, cyber Squatting, cyber vandalism, transmitting virus, cyber trespass, cyber-terrorism, cyber warfare, possession of unauthorized information or any other similar activity. I have fully understood that I am liable to be punished as per the provisions of Section 66 A of Information Technology Act, 2008 and may face imprisonment up to three years along with fine, if a court of law finds me guilty of indulging in any type of cyber crime.

Instructions

1. This form must be filled in by the candidate in his or her own hand in a clear and legible manner.
2. The application form must be completed in all respects. No column should be left unfilled. If any information sought is not applicable to the candidate, the word "N/A" should be entered in writing. If a candidate omits/conceals relevant information or gives false information, his/her admission is liable to be cancelled.
3. All documents like copies of the university certificates, photographs, certificates claiming special status, etc. must be attached with this application. In case the required documents are not attached, the application is liable to be rejected as incomplete.
4. All copies of the certificates, photographs and character certificate, etc., must be self attested and attached.

*** Candidates seeking admission to a course under the category of Sports should submit an additional photocopy of the complete admission form along with self attested photocopies of sports certificates, Class X, Class XII DMC showing the date of birth and original photograph. They are required to appear for trial in a proper sports kit along with their original sports certificates on the university playgrounds as per schedule to be provided to them. Presence of candidate in the field at appointed time is mandatory. No separate intimation will be sent.**

Notes :

1. The candidates should understand that the admission if granted by the university would be provisional and subject to confirmation.
2. Fees/funds and charges payable for various courses by the students shall be as prescribed from time to time.
3. Hostel seats are limited and these will be allotted on the first come first served basis.
4. Students availing scholarship(s) under the government sponsored schemes will be responsible for applying for the same online and completing the formalities including uploading and subsequently submitting the supporting documents to the government/ university as per the procedure prescribed by the government/ university.

In addition to attested copies of academic certificates, the candidate should also attach attested copies of the documents/certificates listed below:

- a. Certificates relevant to claim for a Reserved Category Seat: Each applicant applying for admission in sports category shall, along with application, submit an affidavit, duly attested by a Notary, regarding his/her achievements in sports on a stamp paper and deposit of fee.
- b. Character certificate.
- c. No objection certificate from the employer, if applicable.
- d. Migration certificate (in original).
- e. Affidavit of or about not having been involved in any offence (required in case of a gap in academic career).
- f. Eligibility certificate.
- g. Certificate in support of claim for weightage, wherever specified.
- h. Foreign Nationals/NRI candidates are required to submit relevant certificates.
