The BoS discussed the agenda and unanimously resolved as under:

1. The Board *post facto* approved the proposed outline of syllabi and courses of study for B.Sc. Botany (Hons.)- 1^{st} year of batch 2017 (semester I – VI).

2. The Board *post facto* approved the proposed outline of syllabi and courses of study for the admission to B Se. Botany (Hons.) - 2^{nd} year of batch 2016 (semester I - IV) and 3^{rd} year of batch 2015 (semester III - VI).

3. The Board approved the proposed outline of syllabi and courses of study for the admission to B.Sc. (Hons.) - 2nd year of batch 2016 (semester V - VI).

4. The Board *post facto* approved the proposed outline of syllabi and courses of study for M.Sc. Botany (Hons.)- batch 2017 (semester I - IV).

5. The Board *post facto* approved the proposed outline of syllabi and courses of study for the admission to Misc Botany (Hons.)- 2nd year of batch 2016 (semester I - IV; session 2016-18).

6. The Board approved syllabil of the subjects of Botany to be opted by the students of other departments of the university for the academic session 2016-17, 2017-18, 2018-2019.

7. The Board *post facto* approved the proposed outline of syllabi and courses of study for the admission to Ph D. Botany -1^{st} year of batch 2017 (semester I; session 2017-18).



8. The Board post facto approved the list of examiners and paper setters for 3rd year of Batch 2015, 2nd year of Batch 2016 and 1st year of Batch 2017 of B.Sc. (Hons.) Botany.

9. The Board approved for the list of examiners and paper setters for 2nd year of Batch 2016 and 1st year of Batch 2017 of M.Sc. (Hons.) Botany.

10. The Board approved for the list of examiners and paper setters for 1st year of Batch 2017 of Ph.D. in Botany.

11. Regarding M.Sc. project work, the BoS proposed that in case there are more than ten students in M.Sc. course, then in the II semester, each student shall be given a topic for synopsis, on which he/she shall present a seminar. Meritorious students will be selected on the basis of performance, with two/ three students guided by each faculty member. who would carry out research/review work in the III and IV semester. Rest of the students shall opt for a course (theory and/or practical), for which they shall be examined accordingly.

12. BoS suggested that each Ph.D. student shall be guided by two faculty members (one will be the main supervisor and the other one will be co-supervisor). One faculty member shall supervise at the most, two Ph.D. students and also co-supervise not more than another two Ph.D. students.
