Subject: Minutes of 2nd Board of Studies (BOS) meeting of Department of Computer Science and Applications held on 09-12-2015.

The Second meeting of Board of Studies (BOS) of Department of Computer Science and Applications was held on 09.12.2015 at 1.00 pm in the committee room (Administrative Block). The following members were present:

The members of the BOS discussed and deliberated on the various items of the agenda. Following points emerged out of the meeting:

1) Item 1. Approval of Course Schemes and Syllabi of 2015 batch and onwards for BCA, MCA, B. Sc. (Hons.) Computer Science, and M.Sc. (Hons.) Computer Science

The Course Schemes and detailed Syllabi of 2015 batch and onwards for BCA, B. Sc. (Hons.) Computer Science (*prepared according to Choice Based Credit System proposed by University Grants Commission*) and MCA, M. Sc. (Hons.) Computer Science were presented to the BOS for its approval.

Decision: It was discussed and unanimously resolved to approve the proposed outline of tests, syllabi and courses of reading for above programs of batch 2015 and onwards with following suggestions:

- In the curriculum of BCA, CSA213: Software Engineering and CSA305: System Analysis and Design are repetitive courses. Therefore, System analysis and design should be replaced by information security.
- In course scheme of BCA, CSA310: Web Engineering with ASP.NET should be renamed with Internet Programming with ASP. NET.
- In the course scheme of BSc (CS), CSA178: Operating System should be moved to 3rd semester and CSA273: Internet Technologies and CSA274 should be moved to 4th semester. CSA276: System Analysis and Design should be removed from the 4th semester as this repetition to software engineering course.
- There must be equal weightage to Physics, Mathematics, and Computer Science in the course curriculum of BSc(CS), for more scope of this course to all the three subjects of Physics, Mathematics, and Computer Science.

2) Item 2. To consider *post facto* approval to the proposed Course scheme and Syllabi for the first semester 2015 batches of BCA, B.Sc. (Hons.) Computer Science and MCA, M.Sc. (Hons.) Computer Science.

Decision: It was discussed and unanimously resolved to give *post facto* approval to the proposed course scheme and syllabi for the first semester 2015 batches of BCA, B.Sc. (Hons.) Computer Science and MCA, M.Sc. (Hons.) Computer Science.

3) Item 3. The other items of discussion

- Prof Hardeep Singh emphasized on the starting of a doctoral research program in the department to develop culture of research and increase faculty research output.
- Prof Hardeep Singh advised the university to subscribe the various e-journals of Elsevier, Springer, ACM, IEEE, etc, for faculty and students of Computer Science department. The Journal serves as a means of communication among people across the world who are interested in the teaching and learning of computer science.
